

# THE ENIGMA OF THE FRATRES LUCIS by J. Cretien, D.D.

Kenneth R. H. McKenzie says of the Fratres Lucis: 'A mystic order, established in Florence in 1498. Its members were very much persecuted by the Inquisition. It is a small but compact body, the members being spread all over the world.' It is useless to repeat that its present members disclaim all connection with the Randolph Foundation, and the tatti quanti of commercial mystics, whether from Quakertown or Paris.

There is a tradition, prevailing among prominent mystics of the last century, that this Order was founded by a number of refugee Knights of the Templar Order after it had been outwardly destroyed by the King of France in 1313. The tradition states that thirteen members belonging to the Templars, Cathari, Manichaeans and Albigenses, met in the palace of the Duke of Florence to form an order to perpetuate the Adept Tradition.

In spite of the efforts of the Roman office to destroy these Knights in Italy, they failed as there are no records available in the Vatican which could tell the names of the original Knights. Certain Masonic historians have stated that such men as Pasqualis, Cagliostro, Swedenborg, St. Martin, filiphaz Lévi and many other prominent mystics belonged to this Order, but research has failed to establish any connection with the 'Traites Lucis'.

A. E. Waite attempts to link the 'Fratres Lucis' with the 'Order of the Golden and Rosy Cross' of 1777 in Germany, this is the first definite note we have of this order after its formation in 1498. There seems to be some vague and inconclusive connection with the history of Freemasoury, the Order of the Temple, the Convention of Wilhelmshad and the Rosierucian Order. Careful study of these accounts has failed to establish any evidence that the Fratres Lucis had any connection with the events which took place in 1777.

According to the documents lodged with the Imperial Library at Petrograd, which are reported to have belonged to a Count Wilkoroki of Warsaw, and were translated by the late Mrs. Isobel Ookley, this order appeared in 1780, being incorporated at Berlin, It became known to the public in Vienna after the death of the Empress Maria Theresa and then it was finally broken up in 1795. There is no conclusive evidence available to show that this (Masonic) Order continued to this day.

This Petrograd manuscript clearly states that the Order is connected with the 'Golden and Resy Cross' and that candidates must be first Master Masons. These two claims must be ignored, as there is no evidence that the 'Fratres Lucis' of 1780 is a continuation of or had any connection with the Secret Order of 1498. This is clearly evidenced by the 5th Degree when the candidate becomes a 'Secret Initiate Priest'. This false claim is perpetuated by the Randolph Foundation of America. Perhaps this is where the name 'The Royal Order' ('Fratres Lucis and the Golden and Rosy Cross') and 'The Order of the Illuminati' was manufactured.

There is one question which stands out in all this underworld of occult orders: where is the direct connection between the 1498 'Fratres Lucis' and the German Order of 1780? Obviously there is none, the former existed before Freemasonry came into being in 1717 and was the enemy of the sacerdotal caste as is evidenced by the efforts of the Holy Office of Rome to destroy it. On the other hand, the German Order of the 'Fratres Lucis' was formed in 1780 as a quasi-Masonic body claiming connections with the German 'Golden and Rosy Cross' of 1777.

But the original 'Fratres Lucis' of 1498 still exists. It forms a chain in the Adept Tradition: the number of members, that is to say full Initiates, is always limited to 13. Their ranks are replenished by selection from the defunct Initiate's lay-pupils and they are scattered all over the globe, it is very tare that any pupil is aware of the existence of any other pupil in his area. This self-same rule also applies to the 'Hidden Ruse Cross' and 'Templar Initiates' and is one of the reasons why so little is actually known about them.


